

TERMS AND CONDITIONS - MASTERCARD WEEK:

Preliminary

- Registered users of the Platform using a Mastercard card to make the payment (hereinafter referred to as "Cardholder/You/Your" are eligible to participate in the Campaign on the following terms and conditions. All references to "Card" shall mean Mastercard).
